### FutureLearn's principles




#### Education

FutureLearn is committed to expanding access to quality education and ensuring all its students gain essential knowledge for sustainable development.




### **Equity**

FutureLearn strives to reduce its environmental impact and enhance operational sustainability across our institutions.

FutureLearn continually works to uphold and strengthen its ethical standards through transparency, data security, and responsible governance.



#### SDG 1. End poverty in all its forms everywhere.

- Free courses and geo-course pricing available to encourage individuals to become more economically active.
- Developing employability skills across a wide portfolio of courses and programmes.
- Work experience opportunities made available at FutureLearn.
- All staff are given a charity work day dedicated to a charity of choice.




### SDG 3. Ensure healthy lives and promote well-being for all at all ages.

- First aid training for staff.
- Offering staff personal re-charge days, healthcare plans, and financial contributions to visual aids.
- Access to mental wellbeing services.
- FutureLearn partners with King's College London to provide global health courses that focus on improving healthcare access and sustainable medical practices.



### SDG 4. Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all.

- 100% of students have access to the knowledge and skills needed to promote sustainable development.
- Curricula are developed using an inclusive curriculum framework, providing a socially inclusive learning environment.
- FutureLearn's platform is compliant with Web Content Accessibility Guidelines and considers neurodiversity, disability support, and digital inclusion initiatives.
- Teaching observations ensure the teaching quality is equitable and inclusive.
- All FutureLearn staff have access to continuous professional development through open access to FutureLearn courses.
- Inviting topic specialist guest speakers for students' lectures, seminars, and workshops.
- Appointments of personal tutors within Psychology.
- Working with Trinity College Dublin, FutureLearn offers programmes on inclusive education, supporting teachers and learners in creating ethical and sustainable learning environments.



### SDG 5. Achieve gender equality and empower all women and girls.

- FutureLearn has offered free access to over 1200 courses for women and girls in Afghanistan. Over 44,000 learners have enrolled over the last two years, providing them with the opportunity to take control of their lives.
- An average of 51% of leadership positions are held by women.
- Maternity and Parental Leave benefits are available.
- Flexible working and sabbatical policies are in place.




SDG 8. Promote sustained, inclusive, and sustainable economic growth, full and productive employment, and decent work for all.

- Reducing the consumption of water.




#### SDG 13. Take urgent action to combat climate change and its impacts.

- Recycling available across FutureLearn offices.
- Reduction in the use of paper and greater use of digital tools, supporting Cloud-based partners to achieve net zero by 2030.
- FutureLearn works with Deakin University in Australia to offer courses on sustainability and environmental science, equipping learners with the knowledge to address global climate challenges.
- Implementation of revised work arrangements enabling staff to perform their duties primarily through remote and flexible working models.
- All students are studying entirely online, with no requirement for on-campus attendance or travel.
- FutureLearn partners with EIT RawMaterials to provide free access to courses on e-waste, public health and sustainable development for learners around the world.



SDG 16. Promote peaceful and inclusive societies for sustainable development, provide access to justice for all, and build effective, accountable and inclusive institutions at all levels.

- FutureLearn provides staff and students at Ukrainian universities free enrolment on FutureLearn courses, enabling 60,000 students to continue their learning as part of a global community.
- In partnership with Amnesty International, FutureLearn provides human rights education that empowers individuals to advocate for justice and ethical practices in their communities.



### SDG 17. Strengthen the means of implementation and revitalise the Global Partnership for Sustainable Development.

- FutureLearn has formed a partnership with The International Platform on Sport and Development (sportanddev) to provide free access to online courses in multiple languages on sport and sustainable development for learners around the world.
- FutureLearn collaborates with the British Council to deliver free English language and professional development courses that support learners worldwide in building equitable and ethical career opportunities.
- Through its collaboration with Accenture, FutureLearn delivers free digital skills courses that promote fair access to technology-driven careers, fostering sustainable economic growth.

### **Corporate & Society**


- Embedding FutureLearn's commitments directly into policies, procedures, and everyday practice.
